# An Evening at The Williams Center

Jazz Masters Series:

Paquito D'Rivera with New York Voices in Brazilian Dreams

Wednesday, November 13 at 8 pm with a pre-concert talk beginning at 7 pm Williams Center for the Arts

Plans for the AAUW evening at the Williams Center for the Arts are now finalized, and it is sure to be a wonderful and engaging performance. Tickets for the event will cost \$25 with \$7 going to the scolarship fund. Guests are also invited. An added feature will be a preshow with Paquito at 7 pm and all are encouraged to attend to experience his wit and charm.

A decade ago, two of the most charismatic artists in American jazz—**Paquito D'Rivera** and **New York Voices**—recorded the extraordinary **Brazilian Dreams**, which won the 2003 Grammy for Best Latin Jazz Release.

Both artists, in individual engagements, have thrilled Williams Center audiences over the years. With their lush, stylish vocal arrangements, New York Voices sets new standards for vocal improvisation, and D'Rivera's unrivaled musicianship, melodic flair, and stage presence charms his listeners with tunes that are at once passionate, soulful, and charged with the inner spark of Afro-Cuban swing.

On the occasion of New York Voices' 25th anniversary, the artists have revived this legendary collaboration with new tunes and fresh arrangements, all charged with the double jolt of Afro-Brazilian samba and Cubanismo of D'Rivera's homeland. *The Boston Herald* calls New York Voices "the most exciting vocal ensemble in jazz" and the *Reno Gazette* cites their "sizzling pace that leaves listeners breathless and not quite sure how to assimilate what it is they've heard. Voices takes disciplined uninhibited singing to a new higher level of disjointed unity . . ."

D'Rivera brings vocal fireworks of his own, with virtuosic command of saxophone and clarinet. This legendary jazz statesman captured a slew of major career awards in a three-year span—the NEA Jazz Master award and the National Medal for the Arts (both in 2005), The Kennedy Center Lifetime Achievement in Jazz Award (2007), and the President's Award from the International Jazz Educators (2008).

# New Member Spotlight

### Dr. Nandini Sikand



AAUW Easton welcomes Dr. Nandini Sikand as a new member this month. Nandini is Assistant Professor of an interdisciplinary film and media studies program at Lafayette College. Nandini received her Ph.D in Anthropology from CUNY in 2010. Prior to this appointment she has taught at Swarthmore College, Hunter College, CUNY and Hofstra University. Among her most recent

accomplishments, she was awarded an American Association of University Women (AAUW) postdoctoral fellowship towards her book project, *Bodies, Bells and Borders: Choreographing a New Odissi Tradition*.

Nandini's documentary and experimental films have been screened and won awards at over 100 domestic and international film festivals. Her work has aired on PBS and she has been awarded grants from The Jerome Foundation, the Center for Asian American Media, and she is two-time awardee of the New York State Council on the Arts (NYSCA). Her films include, *The Bhangra Wrap* (1995), *Don't Fence Me In* (1998),

Amazonia (2001), In Whose Name? (2004), Soma Girls (2009), and Cranes of Hope (2011). She also produced the documentary Mahasweta Devi: Witness, Advocate, Writer (2001). In television, she has worked as a producer and director on projects for Channel Four: UK, Ovation: the Arts Network, HBO, Oxygen, and The History Channel. She served on the board of directors of Women Make Movies, a non-profit feminist media distribution organization from 1997 – 2006. She was on the Fulbright IIE National Selection committee for film and video for 2008 – 2011.

Nandini choreographs and performs regularly with her neo-classical Odissi Dance Company, Sakshi Productions (sakshiproductions.org). Her dance work has been funded by LMCC (Lower Manhattan Cultural Council), the Asian American Arts Alliance and Joyce Soho and combines the use of film imagery, live music and elements unique to Indian theatre and performance. She is also the Associate Director/ Choreographer of Harmattan Theater (harmattantheater.com), a performance group committed to an environmentally and socially-engaged theater.

Nandini makes her home on College Hill in Easton with her two sons Armaan, age 7, and Manav, age 5. The AAUW Easton welcomes Nandini to our local branch.

# Federal Circuit Rules in Favor of Veterans Seeking Disability Benefits after Sexual Assaults

In an encouraging step for survivors of military sexual assault, a federal appeals court recently ruled that a veteran's failure to report a sexual assault is not evidence that the assault did not occur. In AZ v. Shinseki and AY v. Shinseki, two veterans sought disability benefits for post-traumatic stress disorder that they said stemmed from sexual assaults they suffered while on active duty. Because the veterans did not file complaints at the time the alleged assaults occurred, their service records did not contain any mention of the assaults. Relying on the veterans' failure to report as evidence that the assaults never occurred, the U.S. Department of Veterans Affairs and the Court of Appeals for Veterans Claims denied disability benefits.

On appeal, the U.S. Court of Appeals for the Federal Circuit held that the "VA may not treat a claimant's failure to report an alleged sexual assault to military authorities as pertinent evidence that the sexual assault did not occur." The court recognized that "many service members fear that the act of reporting a rape to military authorities will subject them to personal and professional reprisals." While other courts are not required to follow it, the ruling is promising. The Federal Circuit's ruling recognizes the real barriers to justice faced by survivors of military sexual assault. AAUW is working to break down those barriers by supporting the lawsuits of survivors and supporting legislation to improve the military's handling of sexual assaults.
