## Leadership Team Model

Our board has been working on a plan for a leadership team where all board members will hold equal responsibilities. The office of President will be eliminated. #### Microaggressions

- Racial microaggressions are common and brief and covert forms of racism.
- The impact of racial microaggressions is as damaging as macroaggressions.
- Microaggressions contribute to the cumulative stress that non-white people experience as part of living with racism.
- It's important that we leverage our privilege to dismantle microaggressions in our workplaces and other social spaces.

#### **Health Equity**

- "To ensure our nation's underserved communities and those disproportionately affected by COVID 19 are being equitably vaccinated against COVID 19, the Health Resources and Services Administration (HRSA) and the CDC have allocated COVID 19 vaccine to HRSA supported Health Centers."
- Over 91% of Health Center patients are individuals or families living at or below 200% of the Federal Poverty Guidelines and nearly 63% are racial/ethnic minorities.
- Health centers across the nation are playing vital roles in supporting local community responses to the COVID 19 public health emergency."

## **Public Policy Update**

#### Why Vote?

Why should I vote in the primary? It's an off year election and not important. I don't know who's running. Local politics don't affect me. I can't leave work. It takes too long.

These are some of the statements and questions that we often hear about why people don't come out to vote.

BUT...voting has never been easier now that we can vote by mail. In states that have had vote by mail for many years, many more people vote than in states where people have to vote in person. For example, in Oregon, where mail in voting has been the law since 1987, 82% of registered voters cast a ballot.

If you have not registered to vote, you have until May 3rd to do so and you can apply for a mail in ballot until May 11th.

Voters have important decisions to make in the May 18th primary. There are a series of questions that allow voters to consider changes to the Pennsylvania constitution. Anyone, regardless of party affiliation, can vote on these questions.

#### **QUESTION 1:**

The first question on your 2021 PA Primary ballot asks whether partisan legislators should be able to terminate a governor's existing emergency declaration, like the one being used now to fight the pandemic.

This amendment would allow partisan politicians to derail nonpartisan emergency response. It could even put Harrisburg gridlock in the way of health experts and first responders.

#### **QUESTION 2:**

Just like the first, the second question on your 2021 PA Primary ballot would strip power from the governor, health experts, and emergency responders to put it in the hands of the gridlocked PA legislature.

In this case, the amendment would automatically terminate emergency declarations after just three weeks. Only the legislature would have the power to extend or renew emergencies.

#### **QUESTION 3:**

The third question on your 2021 PA Primary ballot asks whether the state constitution should specifically prohibit the denial of equal rights based on race or ethnicity.

This amendment offers additional protection against laws or policies that would deny Communities of Color their legal rights. It codifies the progress many Pennsylvanians have fought for for so long.

These important ballot questions show the value of voting in every single election! **Polls are open from 7 AM until 8 PM on Tuesday, May 18th.** You can apply for a mail in ballot using the link below:

In addition to the above questions, candidates are running for a variety of municipal and country government positions, district judgeships and school board seats. Decisions made by our elected officials at the local level can have a greater impact on our lives than decisions on the state or national level.

I urge you to vote in person or by mail and **make your voice heard**.
