# **Brooches: Ornaments of Panache and Political Intrigue**

**Speaker: Donna Murphy** 

Tuesday, September 17, 6:30 pm Palmer Library

Madeleine Albright, our country's 64th Secretary of State, wrote in her 2009 book, *Read My Pins: Stories from a Diplomat's Jewel Box*,

"On good days, I wore flowers and butterflies and balloons, and on bad days, all kinds of bugs and carnivorous animals. I saw it as an additional way of expressing what I was saying, a visual way to deliver a message."

Having spent most of her professional career in the antique and estate jewelry industry, Donna remembers when this book first came out and the excitement it generated. What struck her was how potent these jewels are in their visual imagery and message- designed not only to bedazzle (think Hollywood glam) but also as hidden communicators.

This program, however, will shine a spotlight on the wearing of brooches in our 20th-21st century modern times for a myriad of reasons. From Cartier's "Bird in a Cage" brooch symbolic of the 1940s Nazi invasion of Paris, to the bravado of American women leaders & British royalty wearing brooches with hidden political messages, to who's donning brooches today and why.

Used as metaphors for social commentary, philanthropic causes, political positions, and surprising gender "red carpet" statements, the presentation will dispel the notion that brooches are just another pretty face. It will become apparent that the "Power of the Pin" cannot be denied!

#### AAUW PUBLIC POLICY CONVERSATIONS - SEPTEMBER 2024

In Chicago on August 6<sup>th</sup> the American Bar Association's (ABA) House of Delegates adopted a Resolution declaring the EQUAL RIGHTS AMENDMENT <u>fully ratified as the 28<sup>th</sup> Amendment</u> to the United States Constitution. With a membership of 400,000 lawyers this Resolution empowers the ABA to speak out to answer the claims of ERA opponents in Congress, in the Executive branch and the courts. Senator Kirsten Gillibrand (D/NY) stated:

"The American Bar Association is the premier association of legal minds in the United States and their endorsement of the Equal Rights Amendment as having met the Article V threshold is incredibly important. It shows that constitutional law experts believe the ERA has satisfied all the constitutional requirements to be certified and published. Such a step would enshrine freedom and equality for American women and girls into the Constitution and be the most effective rebuttal available to the disastrous Dobbs decision."

In 2023 Senator Gillibrand introduced the ERA Now Resolution, which directs the archivist of the United States, Coleen Shogan, to affirm the ERA as the 28th Amendment to the United States Constitution, certify the state ratifications and publish it in the Federal Register. The resolution determines that the ERA has met all the requirements of Article V of the Constitution passage by more than two-thirds of Congress in 1972 and ratification by three-quarters of the states.

According to Ms. Magazine (8/15/24), the 15-page ABA report accompanying and supporting the Resolution makes the case for the importance of the ERA, especially today with a Supreme Court embracing a theory of "originalism" that would erase many hard—won rights of women. The report explained that "existing federal and state laws prohibiting sex discrimination are — at best - a "patchwork" because Congress can amend or repeal anti-discrimination laws and the Supreme Court can interpret them narrowly based on social or political bias, "stripping them of much of their force and effectiveness. Statutory provisions thus lack the permanence and authority that constitutional protection of the equality of the sexes would afford."

"The American Bar Association prides itself as the largest voluntary association of lawyers in the world and the national voice of the legal profession." "Particularly in the momentous Presidential election year, with women's rights on the ballot, the ABA must be prepared to speak on the procedural issues that continue to be raised as to the recognition of the ERA as the 28<sup>th</sup> Amendment to the U.S. Constitution," an ABA statement emphasized.

Lacking formal opposition, the Resolution passed by acclamation with ONE lone male voice voting against it out of 546 delegates. Several supporters worried that the current Supreme Court might overturn a long-standing precedent that the 14th Amendment Equal Protection Clause provides certain equality protections to women. ABA President Mary Smith said, it is "foundational to democracy that women have equal rights to fully participate in our democracy. We make up half of the population, but unfortunately, we're lagging in so many areas like equal pay and equal representation in the legal profession." ERA advocates plan to send the ABA Resolution and supporting report to members of Congress, writing letters urging the national archivist to certify and publish the ERA as the 28th Amendment and filing briefs with the U.S. Supreme Court and Courts of Appeals. Backers of the Resolution believe that the ABA will act on the Resolution, urging bar associations to audit federal and state laws for compliance with the ERA.

#### Scholarship Report

One of the recipients from two years ago, Lovett, did not go to Texas A&M for health reasons. She enrolled for the 23-24 year but returned home for ongoing medical reasons. Our \$5,000 contribution was returned to us and put back in the Janney account. We heard she was enrolling on line for the 24-25 year but have not heard from her or her family.

For the 24-25 academic year we awarded three scholarships There was a change in how scholarship monies were allocated by the schools and government and two \$5000 awards were made. The 3rd recipient had some issues with allocation and we agreed to work with them to make the award beneficial to the student and not to the university. I contacted the parent at least 3 times and never had follow-up from her so we still have those funds available. A \$1000 grant was made to our scholarship fund at NCC for two \$500 scholarships. We received letters from the recipients who were most grateful. A \$2500 payment was made for the balance of a 23-24 scholarship to Penn state for Koehler.

# **Financial Report Continued-**
